

Technical Notice 18-017

Index and Sector Index Futures - Opening at 2:00 am

Pursuant to the extension of the Bourse de Montréal Inc. ("the Bourse") trading hours for Interest Rate Derivatives (Technical Notice <u>18-010</u>) on October 9, 2018, the Bourse wishes to inform its participants that it will change the early session opening time for its Index and Sector Index Futures from 6:00 am to 2:00 am in Q1 2019. A subsequent notice will follow to announce the effective launch date.

Consequently, the Bourse wishes to publish the upcoming modifications relative to the trading hours and stages of its Index Futures, in anticipation of the effective date. <u>To avoid undesirable connection failure alerts</u>, please ensure to have your systems and support staff take proper measures to change scheduled connections with the Bourse as of the effective date.

Pre-opening: Order entry, cancellation and modification permitted

No-cancellation: Order entry permitted, cancellation and modification not permitted

Opening: Order entry, cancellation and modification permitted Closing: Order entry, cancellation and modification not permitted

Transactions will continue to be sent to the Canadian Derivatives Clearing Corporation ("CDCC") in real time, as of 2:00 am.
- The extension of the Bourse trading hours also has implications on the CDCC processes. For further information about these changes, please refer to Member Notice 157-17.
- For eligible products, the Basis Trade on Close functionality is available during the regular session only, from 9:30 am to 3:30 pm (ET).
