*** IMPORTANT NOTE ***

As stated in Circular 063-21 published on April 14, 2021, the launch of the Asian trading hours initiative has been rescheduled to September 19, 2021.

ASIAN TRADING HOURS INITIATIVE LAUNCH Activated in Production Sunday May 30, 2021 @ 7PM

In reference to <u>Circular 024-21</u>, Bourse de Montréal Inc. (the "Bourse") will modify its Technical Schedule as follows in both GTE and Production Environments as of the date and times in the Release Schedule, subject to obtaining final regulatory approvals, when applicable. Products in scope and their related trading schedules can be found in the aforementioned Circular.

A subsequent CDCC operational notice will follow to inform Clearing Members of upcoming modifications relative to the clearing components and general testing environment availability, in anticipation of the effective date.

This initiative requires no protocol upgrade.

All times indicated in this document are Eastern Time (ET).

PAR - Instruments

The End of Day Instrument Report for Participants (Instruments_YYYYMMDD.csv.gz) and the Instrument Preview Report (InstrumentsPreview_YYYYMMDD.csv.gz) will be modified as follows:

ExpirationDate	 The field "ExpirationDateTime" will be renamed "ExpirationDate". The time portion will be removed. The format will change from YYYYMMDDHHMMSS to YYYYMMDD, and the length of this field will be 8 characters instead of 14. The date in this field represents the Business Date (and not the calendar date) of 	
	the expiration	
LastTradingDateTime	This field is added to indicate the last trading Date and Time of the product. This new column will be introduced at the end of the report.	

PAR - Trades

The Anonymous Trades (Anonymous Trades_YYYYMMDD.csv.gz) and PostTrade (PostTrade_FIRM_YYYYMMDD.csv.gz) Reports will be modified as follows:

Field	Modification	
DateTime	 The field "Time" will be renamed "DateTime". The date is added to the time in this field, as a trade can occur in the previous calendar day. Hence, the format will change from HHMMSS to YYYYMMDDHHMMSS, and the length of this field will be 14 characters instead of 6. 	

Datalinx

The Trading Summary Reports (MXOptionsTradingSummary_YYYYMMDD.csv.gz and MXFuturesTradingSummary_YYYYMMDD.csv.gz) will be modified as follows:

Field	Modification
ExpirationDate	[Existing Field Modified] 1. The time portion of the field will be removed. The format will change from YYYYMMDDHHMMSS to YYYYMMDD and the length of the field will be 8 characters instead

	of 14.
	2. The field"ExpiryDate" will be renamed "ExpirationDate". The date represents the Business Date of the expiration and not the calendar date.
LastTradingDateTime	[New field] The field "LastTradingDateTime" will be added to indicate the last trading Date and Time of the product. This will be a new column at the end of the report.

Operational Support

The Montréal Exchange will provide the same trading services for the full length of the trading day, regardless of the time, including continuous support (trading, connectivity, operations). MX will be staffed throughout the overnight hours to provide operational and technical support to Approved Participants and Vendors.
