**FINAL CONTRACT ADJUSTMENT**  
**Paramount Resources Ltd. (POU)**  
**Special Cash Dividend**

The Bourse and CDCC wish to inform you that the Directors of Paramount Resources Ltd. (the "**Corporation**"), declared on January 11, 2023, a special cash dividend of CAD \$1.00 per common share. The special dividend will be paid on January 25, 2023 to shareholders of record as of the close of business on January 18, 2023. The ex-dividend date is January 17, 2023.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Paramount Resources Ltd. (POU) options, by an amount equivalent to the special dividend that is CAD \$1.00.

**Special Dividend - Adjustment Details:**

- **RECORD DATE:** January 18, 2023
- **PAYABLE DATE:** January 25, 2023

**CDCC - Adjustment Details:**

According to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Paramount Resources Ltd. (POU) options will be adjusted as follows:

- **EFFECTIVE :** January 17, 2023
- **OPTIONS SYMBOL:** Unchanged
- **NUMBER OF CONTRACTS:** Unchanged
- **MULTIPLIER:** Unchanged
- **DELIVERABLE PER CONTRACT:** 100 common shares of POU

- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will remain unchanged at 75 000 contracts.
- **CUSIP:** Unchanged
- **STRIKE PRICES:** An adjustment of CAD \$1.00 will be made for all existing series.

**Bourse de Montréal Inc. - Adjustment Details:**

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the change and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.
