## **POSITION LIMITS**

### **STOCK OPTIONS INDEX PARTICIPATION UNIT OPTIONS INDEX OPTIONS**

Please be advised that the position limits for net long or short positions in all stock options, index participation unit options and index options listed at Bourse de Montréal Inc. (the Bourse) are outlined in the attached list.

Position limits for stock options and index participation unit options are established and published on a quarterly basis by the Bourse based on the number of shares or units outstanding and the most recent six-month trading volume of the underlying security, in accordance with article 6651 of the Rules of the Bourse.

In accordance with article 6654 of the Rules of the Bourse, we remind you that all approved participants must report, no later than three business days following the last business day of each week, any gross long or short positions in excess of 250 contracts in the case of stock options, 500 contracts in the case of index participation unit options and 1,500 contracts in the case of index options.
