In accordance with the Circular No. 054-12 and the Notice to Members No. 059-12 dated April 4, 2012, this cash amount is equal to the closing price of PPL on April 5, 2012 times 0.5. Hence, the new deliverable per PPL1 contract is as follow:

- **NEW DELIVERABLE PER CONTRACT:** **42 shares of Pembina (PPL) and a cash portion equivalent to 0.5 common share of PPL which is equal to \$14.82**

The cash amount of the deliverable will remain permanently fixed as the option deliverable and will not vary.
