**FINAL CONTRACT ADJUSTMENT
Westport Fuel Systems Inc. (WPRT)
Reverse Split**

The Bourse and CDCC wish to inform you that “Westport Fuel Systems Inc.” (TSX: “WPRT”) will consolidate its Common Shares.

The reverse split on the basis of a one-for-ten ratio will be effective at the opening of the markets on June 6, 2023.

The company will start trading under the new CUSIP on the Toronto Stock Exchange at the opening of business on June 6, 2023.

CDCC - Adjustment Details:

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all WPRT options will be adjusted as follows:

- **EFFECTIVE DATE:** June 6, 2023
- **OPTIONS SYMBOL:** WPRT will become WPRT1
- **NUMBER OF CONTRACTS:** Unchanged
- **MULTIPLIER:** 10
- **NEW DELIVERABLE PER WPRT1 CONTRACT:** 10 common shares of Westport Fuel Systems Inc.
- **STRIKE PRICES:** Strike Prices will be multiplied by ten
- **NEW CUSIP :** 960908 50 7
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will change to 25,000 contracts.

CDCC will not adjust any outstanding escrow receipts.

The Bourse - Adjustment Details:

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the reverse split and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

The existing series of WPRT options class will be transferred to the WPRT1 options class representing the new deliverable.
