**IMPORTANT NOTICE REGARDING THE SYMBOL CHANGES
PUBLISHED BY THE TSX**

Bourse de Montréal Inc. (the Bourse) would like to inform its participants that the Toronto Stock Exchange (TSX) will be making modifications to symbol “roots” on a number of stocks. These adjustments will necessitate changes on 13 underlying option class symbols listed on the Bourse. These changes will occur according to the implementation calendar published by the TSX.

Please note that approved participants will have to **RESET THE INSTRUMENT DICTIONARY** in their systems on Monday mornings in order for the changes to take effect. For further information on this matter, please contact your Independent Software Vendor (ISV).
