**FINAL CONTRACT ADJUSTMENT- Erratum**  
**Horizons Marijuana Life Sciences Index ETF (HMMJ)**  
**Reverse Split**

The Bourse and CDCC wish to inform you that “Horizons Marijuana Life Sciences Index ETF (TSX: “HMMJ”) will consolidate its Common Shares.

The reverse split on the basis of a one-for-two ratio will be effective at the opening of the markets on August 2, 2022.

The company will start trading under the new CUSIP on the Toronto Stock Exchange at the opening of business on August 2, 2022.

**CDCC - Adjustment Details:**

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all HMMJ options will be adjusted as follows:

- **EFFECTIVE DATE:** August 2, 2022
- **OPTIONS SYMBOL:** HMMJ will become HMMJ1
- **NUMBER OF CONTRACTS:** Unchanged
- **MULTIPLIER:** 50
- **NEW DELIVERABLE PER CONTRACT:** 50 common shares of Horizons Marijuana Life Sciences Index ETF (HMMJ)
- **STRIKE PRICES:** Strike Prices will be multiplied by two
- **NEW CUSIP:** 44054J 20 0
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will change to 50,000 contracts

**CDCC will not adjust any outstanding escrow receipts.**

**The Bourse - Adjustment Details:**

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the reverse split and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

The existing series of HMMJ options class will be transferred to the HMMJ1 options class representing the new deliverable.
