**FINAL CONTRACT ADJUSTMENT**  
**BetaPro Natural Gas Inverse Leveraged Daily Bear ETF (HND)**  
**Reverse Split**

The Bourse and CDCC wish to inform you that “BetaPro Natural Gas Inverse Leveraged Daily Bear ETF ” (TSX: “HND”) will consolidate its Common Shares.

The reverse split on the basis of a one-for-ten ratio will be effective at the opening of the markets on September 6, 2022.

The ETF will start trading under the new CUSIP on the Toronto Stock Exchange at the opening of business on September 6, 2022.

**CDCC - Adjustment Details (HND):**

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all HND options will be adjusted as follows:

- **EFFECTIVE DATE:** September 6, 2022
- **OPTIONS SYMBOL:** HND will become HND2
- **NUMBER OF CONTRACTS:** Unchanged
- **MULTIPLIER:** 10
- **NEW DELIVERABLE PER CONTRACT:** 10 common shares of BetaPro Natural Gas Inverse Leveraged Daily Bear ETF
- **STRIKE PRICES:** Strike Prices will be multiplied by ten
- **NEW CUSIP:** 086631 30 6
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will change to 200,000 contracts

**CDCC will not adjust any outstanding escrow receipts.**

**The Bourse - Adjustment Details (HND):**

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the reverse split and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

- **NUMBER OF CONTRACTS: Unchanged**

- **MULTIPLIER:** 1
- **NEW DELIVERABLE PER CONTRACT:** 1 common share of BetaPro Natural Gas Inverse Leveraged Daily Bear ETF
- **STRIKE PRICES:** Strike Prices will be multiplied by ten
- **NEW CUSIP :** 086631 30 6
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits remain unchanged at 75,000 contracts

CDCC will not adjust any outstanding escrow receipts.
