FINAL CONTRACT ADJUSTMENT
BetaPro Crude Oil -1x Daily Bear ETF (HOD)
Reverse Split

The Bourse and CDCC wish to inform you that “BetaPro Crude Oil -1x Daily Bear ETF” (TSX: “HOD”) will consolidate its Common Shares.

The reverse split on the basis of a one-for-four ratio will be effective at the opening of the markets on July 5, 2021.

The company will start trading under the new CUSIP on the Toronto Stock Exchange at the opening of business on July 5, 2021.

CDCC - Adjustment Details:

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all HOD options will be adjusted as follows:

- **EFFECTIVE DATE:** July 5, 2021
- **OPTIONS SYMBOL:** HOD will become HOD1
- **NUMBER OF CONTRACTS:** Unchanged
- **MULTIPLIER:** 25
- **NEW DELIVERABLE PER CONTRACT:** 25 common shares of BetaPro Crude Oil -1x Daily Bear ETF (HOD)
- **STRIKE PRICES:** Strike Prices will be multiplied by four
- **NEW CUSIP :** 08664K 20 4
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will change to 50,000 contracts

CDCC will not adjust any outstanding escrow receipts.

The Bourse - Adjustment Details:

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the reverse split and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

The existing series of HOD options class will be transferred to the HOD1 options class representing the new deliverable.
