**ADDITION TO EQUITY OPTIONS
AND LONG TERM EQUITY OPTIONS SYMBOLS**

Bourse de Montréal Inc. (the Bourse) and Canadian Derivatives Clearing Corporation (CDCC) hereby inform all option participants of the possibility of upcoming additional symbols for new series of equity options and long term equity options on Canadian Natural Resources Limited (CNQ, ZNQ 2009 and WNQ 2010).

Due to recent price fluctuations of the underlying equity for the **CNQ, ZNQ 2009** and **WNQ 2010** options and the lack of strike price alpha codes to identify each series, the Bourse and CDCC will create new symbols – **CNZ, ZQZ 2009** and **WQZ 2010** – to identify options series with a strike price of **eighty-eight dollars (\$88.00) and above**.
