**FINAL CONTRACT ADJUSTMENT**  
**Parex Resources Inc. (PXT)**  
**Special Cash Dividend**

The Bourse and CDCC wish to inform you that the Directors of Parex Resources Inc. (the "Corporation"), declared on November 3, 2021, a special cash dividend of CAD \$0.25 per common share. The special dividend will be paid on November 22, 2021 to shareholders of record as of the close of business on November 16, 2021. The ex-dividend date is November 15, 2021.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Parex Resources Inc. (PXT) options, by an amount equivalent to the special dividend that is CAD \$0.25.

**Special Dividend - Adjustment Details:**

- **RECORD DATE: November 16, 2021**
- **PAYABLE DATE: November 22, 2021**

**CDCC - Adjustment Details:**

According to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Parex Resources Inc. (PXT) options will be adjusted as follows:

- **EFFECTIVE : November 15, 2021**
- **OPTIONS SYMBOL: Unchanged**
- **NUMBER OF CONTRACTS: Unchanged**
- **MULTIPLIER: Unchanged**



- **DELIVERABLE PER CONTRACT:** 100 common shares of PXT
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will remain unchanged at 250 000 contracts.
- **CUSIP:** Unchanged
- **STRIKE PRICES:** An adjustment of CAD \$0.25 will be made for all existing series.

**Bourse de Montréal Inc. - Adjustment Details:**

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the change and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.
