The Bourse and CDCC wish to inform you that the common shares of Petrominerales Ltd. (« Petrominerales ») will be delisted from the Toronto Stock Exchange at the close of business December 4, 2013 as a result of a plan of arrangement through which Pacific Rubiales Energy Corp. acquired all of the issued and outstanding shares of Petrominerales for a cash consideration of \$11.00 CDN per share and one common share of a new company named Alvopetro Energy Ltd (« Alvopetro »).

Bourse de Montréal Inc. - Adjustment details:

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the plan of arrangement and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

The existing series of PMG options class will be transferred to the PRE1 options class representing the new deliverable. Please note that only closing transactions will be permitted on the adjusted class. Actual series that do not have open interest will not be adjusted.
