(«Gildan») announced on February 4, 2015 that its Board of Directors has approved a stock dividend, which has the same effect as a two-for-one stock split of all its outstanding common shares. Each shareholder on the record date of March 20, 2015 will receive, on March 27, 2015, one additional share for each common share held.

The common shares of Gildan are expected to trade on a "due bill" basis on the TSX between market opening on March 18, 2015 and market closing on March 27, 2015.
