FINAL CONTRACT ADJUSTMENT BMO Equal Weight Oil & Gas (ZEO) Reverse Split

The Bourse and CDCC wish to inform you that BMO Equal Weight Oil & Gas ETF ("ZEO") will consolidate its Common Shares. The reverse split on the basis of a one-for-five ratio will be effective at the opening of the markets on January 28, 2019.

CDCC - Adjustment Details:

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all ZEO options will be adjusted as follows:

> **EFFECTIVE DATE:** January 28, 2019

> OPTIONS SYMBOL: ZEO will become ZEO1

NUMBER OF CONTRACTS: Unchanged

> MULTIPLIER: 20

NEW DELIVERABLE PER 20 common shares of BMO Equal Weight Oil & Gas ETF

CONTRACT:

> STRIKE PRICES: Strike Prices will be multiplied by five

> NEW CUSIP: 05585A 20 8

> POSITION AND EXERCISE Position and exercise limits will change to 25,000

LIMITS: contracts

CDCC will not adjust any outstanding escrow receipts.



The Bourse - Adjustment details:

It is important to note that on the effective date mentioned above, all open orders on this option class <u>will not be automatically modified</u> to reflect the reverse split and will therefore have to <u>be re-entered</u> into the Montreal Automated System (SAM) by the approved participants.

The existing series of ZEO options class will be transferred to the ZEO1 options class representing the new deliverable.
