## FINAL CONTRACT ADJUSTMENT Magna International Inc. (MG) Stock Split

The Bourse and CDCC wish to inform you that Magna International Inc. (Magna) announced on February 25, 2015 that the due bill trading procedures will apply to its stock split. Magna shareholders of record on March 11, 2015 will receive one additional share payable on March 25, 2015, for every share held. The common shares of Magna will begin trading on a two-for-one split basis on the Toronto Stock Exchange at the opening of business on March 26, 2015.

The ex-distribution date will be deferred through the use of Due Bills to the first trading day following the payable date.
