The Bourse and CDCC wish to inform you that the Toronto Stock Exchange announced on February 9, 2009, that it has postponed the delisting of Oilexco Inc. ("Oilexco") at the close of market on February 17, 2009. In line with the delisting of Oilexco shares, the Bourse will suspend the trading on the equity options of this company. However, even though these equity options will be suspended from trading, open option positions at CDCC may remain at that date.

These options may continue to be exercised at the purchaser's discretion. On expiry, these positions will **<u>not</u>** auto-exercise and must be processed manually by the clearing member firms.
