Bourse de Montréal Inc. (the Bourse) and Canadian Derivatives Clearing Corporation (CDCC) hereby inform all option participants of the possibility of additional symbols for new series of long term equity options on Husky Energy Inc. (**WHS 2010 and VHS 2011**).

Due to recent price fluctuations of the underlying for **WHS 2010 and VHS 2011** and the lack of strike price alpha codes to identify each series, the Bourse and CDCC will create two new symbols – **WHZ 2010 and VHZ 2011** – for all additional options strike prices of eighteen dollars (\$18.00) and below.
