FINAL CONTRACT ADJUSTMENT Stelco Holdings Inc. (STLC) Special Cash Dividend

CDCC MEMBERS AND BOURSE APPROVED PARTICIPANTS MUST ENSURE THEY HAVE REVIEWED THE DOCUMENTATION PUBLISHED BY THE ISSUERS INVOLVED IN THIS CORPORATE ACTION.

The Bourse and CDCC wish to inform you that the Board of Directors of Stelco Holdings Inc. ("**Stelco Holdings**" or the "**Company**"), approved on February 19, 2019 a special cash dividend of CAD \$1.13 per common share. The special dividend will be paid on March 20, 2019 to shareholders of record as of the close of business on March 13, 2019.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Stelco Holdings Inc.'s (STLC) options, by an amount equivalent to the special dividend that is CAD \$1.13.

CDCC - Adjustment Details:

According to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Stelco Holdings Inc. (STLC) options will be adjusted as follows:

- ➢ <u>NUMBER OF CONTRACTS:</u> Unchanged
- ➢ <u>MULTIPLIER:</u> Unchanged



- > <u>DELIVERABLE PER CONTRACT:</u> 100 common shares of STLC
- <u>POSITION AND EXERCISE</u> <u>LIMITS:</u>
 Position and exercise limits will remain 50 000 contracts.
- ➢ <u>CUSIP:</u> Unchanged
- STRIKE PRICES: An adjustment of CAD \$1.13 will be made for all existing series.

Bourse de Montréal Inc. - Adjustment Details:

It is important to note that on the effective date mentioned above, all open orders on this option class <u>will not be automatically modified</u> to reflect the change and will therefore have to <u>be re-entered</u> into the Montreal Automated System (SAM) by the approved participants.
