FINAL CONTRACT ADJUSTMENT Hudson's Bay Company (HBC) Plan of Arrangement

The Bourse and CDCC wish to inform you that Hudson's Bay Company (TSX: HBC) announced on February 28, 2020, the completion of their previously announced plan of arrangement.

Pursuant to the terms of the Plan of Arrangement, common shareholders of Hudson's Bay Company will receive CAD \$11.00 for each issued and outstanding common share held.

The common shares will be delisted from the Toronto Stock Exchange at the close of business on March 4, 2020.

CDCC - Adjustment Details:

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Hudson's Bay Company (HBC) options will be adjusted as follows:

> EFFECTIVE DATE: March 5, 2020

➤ <u>OPTIONS SYMBOL:</u> HBC will become HBC1

> NUMBER OF CONTRACTS: unchanged

➤ MULTIPLIER: 100

> STRIKE PRICES: Unchanged

CDCC will not accept escrow receipts on these adjusted series.

Bourse de Montréal Inc. - Adjustment Details:

It is important to note that on the effective date mentioned above, all open orders on this option class <u>will not be automatically modified</u> to reflect the plan of arrangement and will therefore have to <u>be re-entered</u> into the Montreal Automated System (SAM) by the approved participants.

The existing series of HBC options class will be transferred to the HBC1 options class representing the new deliverable. Please note that only closing transactions will be permitted on the adjusted class. Actual series that do not have open interest will not be adjusted.
