## ENCANA CORPORATION ADDITIONAL SYMBOL FOR LONG TERM EQUITY OPTION

Bourse de Montréal Inc. (the Bourse) and Canadian Derivatives Clearing Corporation (CDCC) hereby inform all option participants of the possibility of an additional symbol for new series of long term equity options on EnCana Corporation (WEC 2010).

Due to recent price fluctuations of the underlying for WEC 2010 and the lack of strike price alpha codes to identify each series, the Bourse and CDCC will create a new symbol – WEA 2010 – for all additional options strike prices of forty dollars (\$40.00) and below.
