ANTICIPATED CONTRACT ADJUSTMENT Suncor Energy Inc. (SU) Plan of Arrangement

THIS DOCUMENT IS AN UNOFFICIAL SUMMARY OF CERTAIN TERMS OF THE AFOREMENTIONED ADJUSTMENT. CDCC AND THE BOURSE ACCEPT NO RESPONSIBILITY FOR THE ACCURACY OR COMPLETENESS OF THE SUMMARY. CDCC MEMBERS AND BOURSE APPROVED PARTICIPANTS MUST ENSURE THEY HAVE REVIEWED THE DOCUMENTATION PUBLISHED BY THE ISSUERS INVOLVED IN THIS CORPORATE ACTION.

The Bourse and CDCC wish to inform you that Suncor Energy Inc. ("Suncor") and Petro-Canada ("Petro-Canada") announced on March 23, 2009, that they have agreed to merge the two companies. Upon completion of the transaction the parties have agreed that the combined entity will operate corporately and trade under Suncor name. Under the terms of the Arrangement Agreement, Suncor common shareholders will receive 1.00 common share of the merged company for each common share of Suncor they own.

Completion of the proposed merger is conditional on approval of Suncor and Petro-Canada shareholders and certain customary approvals. The companies anticipate that the proposed merger will be completed in the third quarter of 2009.
