## FINAL CONTRACT ADJUSTMENT

BetaPro Crude Oil 2x Daily Bull ETF (HOU)

Reverse Split

The Bourse and CDCC wish to inform you that **BetaPro Crude Oil 2x Daily Bull ETF (TSX:** "**HOU**") will consolidate its Common Shares. The reverse split on the basis of a one-for-ten ratio will be effective at the opening of the markets on March 23, 2020.

## **CDCC - Adjustment Details:**

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all HOU options will be adjusted as follows:

EFFECTIVE DATE: March 23, 2020

OPTIONS SYMBOL: HOU will become HOU1

NUMBER OF CONTRACTS: Unchanged

> MULTIPLIER: 10

> NEW DELIVERABLE PER 10 common shares of BetaPro Crude Oil 2x Daily Bull

CONTRACT: ETF (HOU)

> STRIKE PRICES: Strike Prices will be multiplied by ten

NEW CUSIP: 08662L 20 4

> POSITION AND EXERCISE Position and exercise limits will change to 75,000

LIMITS: contracts

CDCC will not adjust any outstanding escrow receipts.

## The Bourse - Adjustment details:



It is important to note that on the effective date mentioned above, all open orders on this option class <u>will not be automatically modified</u> to reflect the reverse split and will therefore have to <u>be re-entered</u> into the Montreal Automated System (SAM) by the approved participants.

The existing series of HOU options class will be transferred to the HOU1 options class representing the new deliverable.
