FINAL CONTRACT ADJUSTMENT
BetaPro Canadian Gold Miners -2x Daily Bear ETF (HGD)
Reverse Split

THE FOLLOWING INFORMATION IS PREPARED FOR THE CONVENIENCE OF CANADIAN DERIVATIVES CLEARING CORPORATION (CDCC) MEMBERS AND BOURSE DE MONTRÉAL INC. (THE BOURSE) APPROVED PARTICIPANTS. THIS DOCUMENT IS AN UNOFFICIAL SUMMARY OF CERTAIN TERMS OF THE AFOREMENTIONED ADJUSTMENT. CDCC AND THE BOURSE ACCEPT NO RESPONSIBILITY FOR THE ACCURACY OR COMPLETENESS OF THE SUMMARY. CDCC MEMBERS AND BOURSE APPROVED PARTICIPANTS MUST ENSURE THEY HAVE REVIEWED THE DOCUMENTATION PUBLISHED BY THE ISSUERS INVOLVED IN THIS CORPORATE ACTION.

The Bourse and CDCC wish to inform you that **BetaPro Canadian Gold Miners -2x Daily Bear ETF** (TSX: "HDG") will consolidate its Common Shares. The reverse split on the basis of a one-for-four ratio will be effective at the opening of the markets on March 23, 2020.

CDCC - Adjustment Details:

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all HGD options will be adjusted as follows:

- **EFFECTIVE DATE:** **March 23, 2020**
- **OPTIONS SYMBOL:** **HGD will become HGD1**
- **NUMBER OF CONTRACTS:** **Unchanged**
- **MULTIPLIER:** **25**
- **NEW DELIVERABLE PER CONTRACT:** **25 common shares of BetaPro Canadian Gold Miners - 2x Daily Bear ETF (HGD)**
- **STRIKE PRICES:** **Strike Prices will be multiplied by four**
- **NEW CUSIP :** **08661 P 206**
- **POSITION AND EXERCISE LIMITS:** **Position and exercise limits will change to 75,000 contracts**

CDCC will not adjust any outstanding escrow receipts.

The Bourse - Adjustment details:

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the reverse split and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

The existing series of HGD options class will be transferred to the HGD1 options class representing the new deliverable.
