SPONSORED OPTIONS – SOCIÉTÉ GÉNÉRALE

Please be advised that the position limits for positions in all Société Générale sponsored options listed at Bourse de Montréal Inc. are outlined in the attached list.

Position limits are established and published on a quarterly basis by the Bourse based on the number of shares outstanding and the most recent six-month trading volume of the underlying interest, as described in article 6651 of the Rules of Bourse de Montréal Inc.

We remind you that all approved participants must file with the Bourse a report in the same form as the one required for standard options when net positions held by a person or an entity or by a group of persons or entities under common control are in excess of the reporting level. This report must be filed no later than three business days following the last business day of each week, as described in article 6654 of the Rules of Bourse de Montréal Inc.
