MODIFICATION OF THE MINIMUM QUOTATION SPREAD FOR EQUITY, INDEX PARTICIPATION UNIT AND INDEX OPTIONS CONTRACTS

EXPANSION OF THE PENNY PILOT PROGRAM

As part of decision 2009-OAR-0024 rendered by the Autorité des marchés financiers (the AMF) on November 30, 2009 authorizing the extension of the Penny Pilot Program until February 28, 2011, the Bourse will add 60 new classes throughout the course of 2010, at the rate of 15 classes per quarter.

An additional class will be added to this quarter to replace Nortel Networks Corp. (NT) that was removed from the Penny Pilot Program due to the delisting of the underlying security.
