## FINAL CONTRACT ADJUSTMENT Horizons BetaPro S&P/TSX Capped Energy Bear Plus ETF (HED) Reverse Unit Split

(THE BOURSE) APPROVED PARTICIPANTS.</u> THIS DOCUMENT IS AN UNOFFICIAL SUMMARY OF CERTAIN TERMS OF THE AFOREMENTIONED ADJUSTMENT. CDCC AND THE BOURSE ACCEPT NO RESPONSIBILITY FOR THE ACCURACY OR COMPLETENESS OF THE SUMMARY. CDCC MEMBERS AND BOURSE APPROVED PARTICIPANTS MUST ENSURE THEY HAVE REVIEWED THE DOCUMENTATION PUBLISHED BY THE ISSUERS INVOLVED IN THIS CORPORATE ACTION.

The Bourse and CDCC wish to inform you that Horizons ETFs Management (Canada) Inc. ("Horizons ETFs") will consolidate the units of Horizons BetaPro S&P/TSX Capped Energy Bear Plus ETF ("HED"). The reverse unit split on the basis of a 1 for 4 ratio will be effective at the opening of markets on June 19, 2014.

#### **CDCC** - adjustment details:

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all the HED options will be adjusted as follows:

➤ EFFECTIVE DATE: June 19, 2014

> OPTIONS SYMBOL: HED will become HED1

➤ <u>Number of Contracts:</u> Unchanged

> POSITION AND EXERCISE The position and exercise limits will remain unchanged at

CDCC will not adjust any outstanding escrow receipts.

### **The Bourse - adjustment details:**

It is important to note that on the effective date mentioned above, all open orders on this option class <u>will not be</u> <u>automatically modified</u> to reflect the reverse split and will therefore have to <u>be re-entered</u> into the Montreal Automated System (SAM) by the approved participants.

The existing series of HED options class will be transferred to the HED1 options class representing the new deliverable. Actual series that do not have open interest will not be adjusted.

## Numerical Example

For a member holding a long put strike \$4.00 position and considering that HED Fund's closing price on June 16, 2014 is \$2.07, the intrinsic value of the option prior to the adjustment is:

After the adjustment, the intrinsic value of the option will be:

Intrinsic Value = New Strike Price x New Multiplier – New Underlying Market Price x New Deliverable
