## **POSITION LIMITS - FUTURES CONTRACTS**

Bourse de Montréal Inc. (the Bourse) establishes and publishes on a monthly basis the position limits for all futures contracts in accordance with articles 15508, 15608, 15708, 15758, 15809 and 15908 of the Rules of the Bourse. You will find below the new position limits for the futures contracts listed at the Bourse, indicated as a number of contracts (cts) for all net long or net short positions in all contract months combined. These new limits **are effective immediately**.

**Important Notice**: In order to facilitate the processing of position reports filed with the Bourse, we require that our approved participants must submit their position report within the 48 hours of the close of the  $2^{nd}$  and  $4^{th}$  business day of each weak.
