FINAL CONTRACT ADJUSTMENT Horizons BetaPro NYMEX Natural Gas Bull Plus ETF (HNU) **Reverse Unit Split**

DOCUMENT IS AN UNOFFICIAL SUMMARY OF CERTAIN TERMS OF AFOREMENTIONED ADJUSTMENT. CDCC AND THE BOURSE ACCEPT NO RESPONSIBILITY FOR THE ACCURACY OR COMPLETENESS OF THE SUMMARY. CDCC MEMBERS AND BOURSE APPROVED PARTICIPANTS MUST ENSURE THEY HAVE REVIEWED THE DOCUMENTATION PUBLISHED BY THE ISSUERS INVOLVED IN THIS CORPORATE ACTION.

The Bourse and CDCC wish to inform you that Horizons ETFs Management (Canada) Inc. ("Horizons ETFs") will consolidate the units of Horizons BetaPro NYMEX Natural Gas Bull Plus ETF ("HNU"). The reverse unit split on the basis of a 1 for 10 ratio will be effective at the opening of markets on November 26, 2015.

CDCC - adjustment details:

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all HNU options will be adjusted as follows:

CDCC will not adjust any outstanding escrow receipts.

The Bourse - adjustment details:

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the reverse split and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

The existing series of HNU option class will be transferred to the HNU5 option class representing the new deliverable. Actual series that do not have open interest will not be adjusted.
