FNX MINING COMPANY ADDITION OF AN EQUITY OPTION SYMBOL

Bourse de Montréal Inc. (the Bourse) and Canadian Derivatives Clearing Corporation (CDCC) hereby inform all option participants of the possibility of an upcoming symbol addition for new series of equity options on FNX Mining Company (FNX).

Due to recent price fluctuations of the underlying for FNX and the lack of strike price alpha codes to identify each series, the Bourse and CDCC will create a new symbol - **FNZ** - **for all additional options strike prices of eight dollars (\$8.00) and below.**
