MODIFICATION OF THE MINIMUM QUOTATION SPREAD FOR EQUITY, INDEX PARTICIPATION UNIT AND INDEX OPTIONS CONTRACTS

REPLACEMENT OF CLASSES

As part of decision 2013-SMV-0019 rendered by the Autorité des marchés financiers (the AMF) on February 27, 2013 authorizing the extension of the Penny Pilot Program until February 28, 2014, Bourse de Montréal Inc. (the Bourse) has been authorized to proceed with the periodical replacement in the Program of classes that have been delisted from the Bourse. New classes will be added to the Penny Pilot Program each time there is a plan of arrangement that affects a class included in the Program.

The Bourse has modified certain classes in the Penny Pilot Program following changes in the underlying shares. These modifications reflect either, a change of name, a plan of arrangement or the replacement of a class. Volume of activity on the class during the six preceding months, market demand, and whether the class is interlisted on a US exchange will be the determining criteria for the replacement of a class.

Crescent Point Energy Corp. (CPG) will be added in replacement of Aurizon Mines Ltd. (ARZ) that was delisted from the Toronto Stock Exchange at the close of business on June 5, 2013. (the Bourse's circular no. 107-13). The Bourse will keep in the penny pilot program the series of Aurizon Mines Ltd. options that have open interest. (ARZ1).

Canadian Oil Sands (COS) and First Quantum Minerals (FM) will be added in replacement of Jaguar Mining Inc. (JAG) and QLT Inc. (QLT) which will be removed due to the fact that they no longer qualify for the program.

Husky Energy Inc. (HSE) will be added in replacement of Uranium One Inc. (UUU) that will exit the program following October expiry. (the Bourse's circular no. 016-13). The Bourse will keep in the penny pilot program the series of Uranium One Inc. that have open interest.

The Bourse modified the name and symbol of Harry Winston Diamond Corp.(HW) to Dominion Diamond Corporation (DDC) (the Bourse's circular no. 048-13).

The Bourse modified the name of Agnico-Eagle Mines Ltd. to Agnico Eagle Mines Limited (the Bourse's circular no. 083-13)

The Bourse modified the name of Coeur D'Alene Mines Corporation to Coeur Mines Inc. (the Bourse's circular no. 091-13).

The Bourse modified the name of Research in Motion Limited to BlackBerry Limited (the Bourse's circular no. 130-13).

All these changes are reflected in the table below. Classes listed in Schedule A will be part of the Penny Pilot Program starting Friday August 23, 2013.

All series of the XEG, XFN, XGD and XIU option classes and all series priced below \$3.00 in the other equity options classes listed in Schedule A will be quoted in pennies. Series priced \$3.00 and higher in all options

classes in Schedule A, other than XEG, XFN, XGD and XIU options series, will be quoted in increments of \$0.05.
