**FINAL CONTRACT ADJUSTMENT  
Dream Global Real Estate Investment (DRG)  
Acquisition**

The Bourse and CDCC wish to inform you that the affiliates of real estate funds managed by Blackstone (collectively, "Blackstone") of Dream Global REIT (TSX: DRG.UN) ("Dream Global" or the "REIT") has completed the acquisition of all subsidiaries and assets in an all-cash transaction.

Pursuant to the terms of the Acquisition Agreement, unitholders of Dream Global REIT will receive CAD \$16.79 for each issued and outstanding Unit held.

The Units will be delisted from the Toronto Stock Exchange at the close of business on December 11, 2019.

**CDCC - Adjustment Details:**

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Dream Global REIT (DRG) options will be adjusted as follows:

- **EFFECTIVE DATE:** December 12, 2019
- **OPTIONS SYMBOL:** DRG will become DRG1
- **NUMBER OF CONTRACTS:** unchanged
- **MULTIPLIER:** 100
- **STRIKE PRICES:** Unchanged
- **NEW DELIVERABLE PER CONTRACT:** A cash consideration of CAD \$1679.00
- **POSITION AND EXERCISE LIMITS:** The position and exercise limits will remain unchanged at 200, 000 contracts.

CDCC will not accept escrow receipts on these adjusted series.
