## FINAL CONTRACT ADJUSTMENT Enercare Inc. (ECI) Plan of Arrangement

The Bourse and CDCC wish to inform you that Enercare Solutions Inc. ("Enercare") and Brookfield Infrastructure and its institutional partners (collectively, "Brookfield") announced on October 16th, 2018, the completion of their previously announced plan of arrangement under section 192 of the *Canada Business Corporations Act* (the "Arrangement").

Pursuant to the terms of the Arrangement, shareholders of Enercare Inc. will receive CAD \$29.00 for each issued and outstanding common share held.

The common shares will be delisted from the Toronto Stock Exchange at the close of business on October 17, 2018.
