FINAL CONTRACT ADJUSTMENT Kinder Morgan Canada Ltd. (KML) Plan of Arrangement

The Bourse and CDCC wish to inform you that Pembina Pipeline Corporation ("Pembina") (TSX: PPL; NYSE: PBA) and Kinder Morgan Canada Limited ("Kinder Morgan Canada") (TSX: KML) announced on December 16, 2019, the completion of their previously announced plan of arrangement.

Pursuant to the terms of the Plan of Arrangement, common shareholders of Kinder Morgan Canada will receive 0.3068 of a common share of Pembina for each issued and outstanding common share held.

The common shares will be delisted from the Toronto Stock Exchange at the close of business on December 18, 2019.

CDCC - Adjustment Details:

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Kinder Morgan Canada Limited options will be adjusted as follows:
