The Bourse and CDCC wish to inform you that GENIVAR Inc. (“GENIVAR”) announced on December 30, 2013 that its common shares will start trading under a new name, symbol and CUSIP on the Toronto Stock Exchange at the opening of business on January 2, 2014.

CDCC - Adjustment Details:

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all GNV options will be adjusted as follows:

- **EFFECTIVE DATE:** January 2, 2014
- **OPTIONS SYMBOL:** GNV changes to WSP
- **NUMBER OF CONTRACTS:** Unchanged
- **MULTIPLIER:** Unchanged
- **DELIVERABLE PER CONTRACT:** 100 common shares of WSP Global Inc. (WSP)
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will remain unchanged.
- **NEW CUSIP :** 92938W202

Bourse de Montréal Inc. - Adjustment Details:

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the change and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

The existing series of GNV options class will be transferred to the WSP options class representing the new deliverable.
