## FINAL CONTRACT ADJUSTMENT Granite Real Estate Investment Trust (GRT) Special Cash Dividend

The Bourse and CDCC wish to inform you that Granite Real Estate Investment Trust ("Granite") board of trustees declared on December 17, 2018 a special dividend of CAD \$0.30 per stapled unit.

The special dividend will be paid on January 15, 2019 to shareholders of record as of the close of business on December 31, 2018. The ex-dividend date is December 28, 2018.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Granite Real Estate Investment Trust options, by an amount equivalent to the special dividend that is CAD \$0.30.
