**RESTATEMENT OF FIVE-YEAR GOVERNMENT OF CANADA BOND FUTURES (CGF)
OPEN INTEREST**

Following the publication of [Circular 206-18](#) on December 28, 2018, Bourse de Montréal Inc. (the “Bourse”) hereby wishes to inform its participants that the Canadian Derivatives Clearing Corporation (“CDCC”) has reviewed the open interest figures for the Five-Year Government of Canada Bond Futures (CGF) March 2019 quarterly expiry. The open interest statistics published by the CDCC for certain trading days were erroneous as they reflected certain trade booking errors which have resulted in the overstatement of CGF open interest.

After review, the corrected open interest statistics are as follows:
