**iSHARES CDN S&P/TSX CAPPED FINANCIALS INDEX FUND
ADDITIONAL SYMBOL FOR AN INDEX OPTION**

Bourse de Montréal Inc. (the Bourse) and Canadian Derivatives Clearing Corporation (CDCC) hereby inform all option participants of the possibility of an additional symbol for new series of index options on iShares CDN S&P/TSX Capped Financials Index Fund (XFN).

Due to recent price fluctuations of the underlying for XFN and the lack of strike price alpha codes to identify each series, the Bourse and CDCC will create a new symbol – **XNF** – **for all additional options strike prices of thirteen dollars (\$13.00) and below.**
