### 5Y bond futures (CGF) volume up 507% YoY

- Daily volume record: 24k (Mar 27)
- Monthly volume record: 229k (Mar)
- Open interest record: 36k (Feb 20)
- CGF/CGB strategy ADV: 960 contracts

#### 10Y bond futures (CGB) volume up 23% YoY

- Daily volume record: 943k (Feb 22)
- Open interest record: 1.12M (Feb 22)

### **Market Commentary**

#### Share Futures volume up 304% YoY

- Daily volume record: 105k (Feb 12)
- Monthly volume record: 306k (Jan)

- Daily volume record: 260k (Mar 11)
- Open interest record: 518k (Mar 11)
- Monthly BTC\* volume record: 1.3k ADV

### **Market Commentary**

The Canadian stock market had its greatest start since year 2000 (up 12.4%), helping to forget the December meltdown. The healthcare sector led the way, up 49%. Given this strong performance, market volatility has dropped significantly compared to Q4 2018.

### **Key Milestones and Facts**

### Q1 is a strong start into 2019

- Overall average daily volume **up 11%** YoY (476k)
- 2nd highest quarterly volume in history (29.5M contracts traded)
- 4th highest monthly volume (March, 10.6M contracts traded)
- March volume up 29% YoY (503k ADV)
- 9 new volume and OI records established

# SXF and other Index Futures now available to trade as of 2 a.m. ET

The extension of MX trading hours on its Index futures suite was successfully launched on February 25th. March statistics (during the 2 a.m. to 6 a.m. period)

- Over 8,500 contracts traded
- Average daily volume of 404 contracts, with some days over 1,000 contracts.
- Over 30 participating firms

## 5Y bond futures adoption is consistently increasing

CGF successfully went through its first quarterly roll since launch. Key March statistics:

- Average daily volume over 10k contracts
- Open interest reached **35k contracts**
- Average bid-ask spread: 0.013 ticks

# CGF/CGB spread strategy is now quoted and traded

The 2:1 ratio strategy is a convenient way to get 5Y/10Y curve spread exposure. The pricing is 2xCGF - 1xCGB.

# New BAX Reds and Greens market making program

Effective since March 1, this new program enables greater market quality in BAX second and third year of quarterly expiries. First month results (BAX R&G):

- ADV of 50k (up 59% vs March 2018)
- Volume now represents 35% of total BAX volume

## Extended hours market data analysis
